MOTION TO EXTEND TIME TO FILE SCHEDULES AND OTHER DOCUMENTS

Lexington Blue, Inc. (“Debtor”), by and through counsel, hereby requests an order extending the time to file Schedules A–H and other lists, applications, disclosures and declarations and to transmit certain documents to the Chapter 11 Trustee.

1. Debtor filed a skeletal petition under chapter 11 of the bankruptcy code on June 16, 2025.
2. On June 17, 2025, Debtor was ordered to file Schedules A–H and other lists, applications, disclosures and certain declarations required by the Code [Doc. 5].
3. Debtor has worked diligently but has been unable to gather all the documents and information which would allow it to complete the required filings. Moreover, counsel has not had sufficient time to review the documents that he has received thus far, nor has counsel had the opportunity to discuss those documents with Debtor.
4. Debtor requests an additional 14 days to complete the required filings and comply with the orders in this case.
5. Pursuant to Local Rule 9013-1(c)(xv) a court may grant, without requiring notice and/or hearing, a motion to extend time within which to file schedules and other required documents.

WHEREFORE, Debtor respectfully requests that this Court enter an order extending by 14 days, the deadlines set forth in Doc. 5.
